**POLICY**

The ACGME requires that the Sponsoring Institution (SI) maintain a policy that addresses the loss of accreditation for patient care or restriction/loss of approved licensure to conduct patient care in the SI and/or major participating sites.

**SCOPE**

This policy applies to Valley Health Team, Inc. Graduate Medical Education and the ACGME requirements for the SI and participating sites.

**PURPOSE**

Valley Health Team, Inc. is committed to the maintenance of high quality Graduate Medical Education programs. This policy outlines the procedures that must be followed in the event the Sponsoring Institution or participating sites closes due to the loss of accreditation and/or licensure to conduct patient care.

**PROCEDURE**

**Loss of Accreditation:** If the SI or major participating site that is a hospital loses its accreditation for patient care, the SI must notify and provide a plan for its response to the Institutional Review Committee (IRC) within 30 days of such loss. Based on the particular circumstances, the ACGME may invoke its procedures related to alleged egregious and/or catastrophic events.

**Loss of License:** If the SI's, or participating site's license is denied, suspended, or revoked, or when a SI or participating site is required to curtail activities, or is otherwise restricted, the SI must notify and provide a plan for its response to the IRC within 30 days of such loss or restriction. Based on the particular circumstances, the ACGME may invoke its procedures related to alleged egregious and/or catastrophic events.
